## 2. Intro on Independent SAGE and questions

Zack King introduced the work of Independent SAGE (iSAGE) to date. This is based on informal meetings of the main group who, to date have produced four reports, the latest of these being on the testing process. The next focus is likely to be on BAME issues. Additionally, iSAGE has used its media contacts to conduct media events and public consultations. Our new group can feed into the work of iSAGE in a number of ways:

- Through adding a behavioural science dimension to iSAGE papers
- Through producing our own papers and reports, but discussing them with the overall group and publish under the aegis of iSAGE.
- Through conducting our own media and public events, but involving members of <u>iSAGE</u> (particularly Sir David King) on them

In terms of process, our group will meet separately and feed into <u>iSAGE</u> through Susan Michie and Steve Reicher who currently belong to the main group. <u>However</u> the identity of those in the main group is open to discussion in future meetings.

The public are very hard pressed at the moment and amidst growing poverty and unemployment I dont feel easy about raising money and it changes the basis of our effort.

It would be good to explore the volunteer route as some of my young colleagues are on furlough and as Martin says there are lots of volunteers. I would be happy to help support and pay for an editor.

Thanks for your email.

Here are my concerns and questions re crowdfunding.

First I confess to being a bit surprised by the crowd funding proposal, we haven't yet discussed the pros and cons and it wasn't the basis upon which we were invited.

Before we decide anything, surely we need to understand what we need the money for and how much and for how long and exactly who for? We have already decided to recruit RAs and people on furlough and volunteers.

Everyone on the committee is in employment and some of us are on very good salaries. So, should we not be contributing if we need to, what we can afford, once we have the answers to the questions, that would be public spirited and in the spirit of what we are doing.

The public are very hard pressed at the moment and I don't feel at all comfortable crowdfunding - there are other issues - but these are secondary to the key questions.

I am very happy to make a financial contribution.
